## **Estimated Cost Per Person for 2024**

\$1500 (includes estimated airfare)\* \$900 (does not include airfare)\*\*

\*Airline prices fluctuate significantly in the months leading up to a trip. This makes it impossible to know the flight cost for certain until the time of purchase. The cost per person has been set based on historical flight prices, but the actual cost per person could change in either direction. Tickets are usually purchased 2-3 months prior to the trip (during the window of historically-lowest prices) thus providing adequate time to communicate the actual overall cost increase or decrease.

\*\*Please note that if you choose to supply your own air transportation (purchase your own ticket or rely on a standby pass), you might arrive in Guatemala or depart from Guatemala on a different flight thus a different itinerary from the team. If this happens, then you will be responsible for paying the additional expense of ground transportation to & from the House of Healing.
